1) Eligibility Criteria/technical Qualification: -

The bidder should satisfy the below mentioned criteria and should invariably submit valid documentary evidence to support the eligibility claim:

- A) The bidder should be duly registered with the concerned Central/State Govt. authorities and should be well established Service Provider (Agency/Firm) (hereinafter referred to as the agency/firm) preferably having experience to provide internet services to Central/State Government or PSUs to which they have extended similar services in past two years.
- B) The bidder should be duly registered with the concerned Central/State Govt. authorities and should be well established Service Provider (Agency/Firm) (hereinafter referred to as the agency/firm) preferably having experience to provide internet services to Central/State Government or PSUs to which they have extended similar services in past two years.
- C) The Firm should also have a minimum turnover of Rs. 10, 00,000/- (Rupees Ten Lacs/-) per annum in the last three years
- D) He should possess a Shop & Establishment Certificate, G.S.T. and Income-tax Registration Certificate & PAN Card.
- E) Rates once finalized will be valid for a period of one year.
- F) The bidder should be a company registered under the Companies Act, 1956/2013 and should have been in the business for more than 5 years. The following documents may be submitted in support: a.) Copy of Certificate of Incorporation, b.) Copy of Memorandum & Articles of Association.
- G) The bidder should not have been debarred or blacklisted by any Central / State Government or any State Government Department(s) and the bidder should not have any litigation pending in any of the Court(s). - I) Bidder should have its own International gateways & gateways should be operational. DOT License/Certificate for the same to be provided in the technical bid.
- j) Bidder has to submit their clientele list. A list of clients where similar services have been provided in the past three years should be furnished with particulars like name of the organization, bandwidth supplied, contract start date, contract end date, name, address & phone number of contact person

- K) The bidder must have a fully functional Customer Service Centre(s) / contact support Centre with 24 X 7 X 365 support. The bidder should have Toll Free number for fault registering, operating on 24 X 7 X 365 basis. List of Customer Service Centre(s) must be enclosed with technical bid enclosed.
- L) The bidder should have executed (during last 3 years) at least one project for implementation of internet bandwidth of capacity 50 Mbps or above. Detail of such projects to be provided.
- M) Bidder should have online tools to monitor the link performance.
- N) The bidder should have adequate bandwidth at the backend to provide the service.
- P) The bidder should have local peering within India with at least one other Category "A" ISP.
- Q) The bidder should ensure that the local loop provisioning does not violate any regulations as laid by Government of India/ TRAI in respect of such links/ networks. Bidder shall be responsible for making all the payments towards the local loop charges /rentals/WPC charges etc.
- R) The bid of any bidder who has not complied with one or more of the conditions of eligibility criteria and / or fail to submit the required documents as required / or mentioned in tender document are liable to be summarily rejected.

2) LOCAL CONDITIONS:

It shall be the responsibility of each tendered to fully inform/ acquaint / familiarize itself with local conditions and factors, which may have any effect on the execution of services to be rendered under the contract. All bidder(s) intending to bid shall visit and make themselves thoroughly acquainted with the local site conditions. The college shall presume that the tendered has understood and agreed that all the relevant factors have been kept in view while submitting the bid. No financial adjustment arising thereof shall be permitted by Institute, on the basis of any non-clarity of information about local conditions being pleaded by the bidder. Further, no claim for any financial adjustment shall be entertained by the department under any circumstances as part of the contract awarded on this tender document.

3) INSTALLATION & COMMISSIONING:

Project shall be completed within one weeks from the date of issue of the Letter of Intent (LOI)/ Work order. All the aspects of safe delivery, installation, commissioning and uplink of the connectivity shall be the exclusive responsibility of the Service Provider. If the Service Provider fails to uplink the connectivity by the specified date, then the penalty at the rate of 1% per week of the total order

value subject to maximum of 10% of total order value will be deducted and thereafter the offer shall automatically stands cancelled.

4) SERVICE PROVIDER OBLIGATIONS:

The Service Provider shall be responsible for providing the Internet leased line connectivity of 50 Mbps symmetric bandwidth without any compression factor (Full Duplex, Dedicated (1:1), unshared, and uncompressed) with last mile connectivity on fibered to be terminated at UTM at Govt. V.Y.T.PG. Autonomous college, Durg, 491001(C.G.) at all the time throughout the contract period.

- a. The Service Provider shall be responsible for Govt. V.Y.T.PG. Autonomous college, Durg, 491001(C.G.), commissioning and configuring of hardware and uplink of connectivity
- b. Liaising (if required) with other firm(s) for obtaining point to point connectivity between ISP node and department, shall be the responsibility of the Service Provider.
- c. The Service Provider would insure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks. Service Provider shall be responsible for making all the payments towards the local loop charges /rentals/WPC charges etc.
- d. The Service Provider will do preventive maintenance once a quarter for upkeep of the systems running. The schedule will have to be adhered to strictly by him.

5) SERVICE LEVEL GUARANTEE:

- a. The Service Provider shall provide Internet leased line connectivity of 50 Mbps symmetric bandwidth without any compression factor (Full Duplex, dedicated (1:1), unshared, and uncompressed) with last mile connectivity on fiber at all the time (24 X 7X365) at Govt. V.Y.T.PG. Autonomous college, Durg, 491001(C.G.).
- b. To provide Internet Router Port at ISP Gateway for required Bandwidth.
- c. Packet Losses: Less than 1 %(Average over 1000 ping) at any given point of time to any part of Country / ISP Internet gateway.
- d. Latency: Less than 100ms from the department to ISP's tier 1 peering point. Latency will be randomly checked on daily basis. In case of non-adherence latency limit, the link will be considered as down with effect from time of detection till the time is restored.
- e. Network Availability (uptime): More than 99.9 %per month.
- f. National Backbone should be available on the same ISP.
- g. Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis.

- h. Downtime Calculation: Downtime shall be calculated as (Total Time - Down Time) X100/Total Time. Deduction in payment will be made for downtime in the six monthly bills raised by the ISP.
- i. The response time for attending the faults will be 1 hour after they are reported to the ISP. The ISP will rectify the faults within 12 hours failing which; the bidder will arrange temporary replacements. The services shall be provided 24 X 7 days in a week.
- j. Mean Time to Repair (MITR), Packet loss and Link failover will be calculated from network Management System (NMS) at Institute side or through ISP portal.

- l. Link down due to power failure / or any situation which are beyond the control of service provider.
- m. Due to schedule maintenance by the Service Provider, with prior approval of department.

6) OTHER TERMS AND CONDITIONS:

1. Bidders shall submit the financial bids strictly as per the format attached with this tender. Financial bids containing any fresh conditions (not mentioned in the technical Bid) shall be liable for rejection. Bids must be submitted within the stipulated date and time as indicated in the tender and should be valid for a period of 180 days from the final date of submission of tender.
2. Any bidder who wishes to quote against this tender may download the bidding document from this office website (www.govtsciencecollegedurg.ac.in) and submit the bids complete in all respect offline on or before the due date/time along with an undertaking that the contents of the bidding documents have not been altered or modified.
3. The bidders are required to submit photo copies of all certificates/documentary evidences towards the proof of meeting the eligibility criteria along with other requisite documents through our tender system. Non-submission of the photo copies of the requisite certificates/documents shall render the bid non-responsive and shall be liable for rejection.
4. This is zero deviation tender. Bidders are strictly advised to confirm compliance of tender conditions and not to stipulate any deviations in their offer. Subsequent to bid submission, this office shall not seek

confirmation/clarifications and any bids which are not in line with tender conditions shall be liable for rejection. Bidders are also requested to submit the documents/confirmations strictly as per the check list enclosed. Any change in bid after the due date of submission is not allowed.

5. Office of the Principal Govt. V.Y.T.PG. Autonomous College, Durg, 491001(C.G.)reserves the right to cancel the contract at any time after acceptance of the same with a notice. The Contractor/Supplier shall have no claim to any payment of compensation or otherwise whatsoever, on account of any profit or advantage which he might have derived from the execution of the work/supply in full but he did not derive inconsequence of the foreclosure of the whole or part of the works. The Contract shall be valid for a period of one year i.e. from the date of issuance of the contract. Office of the Principal Govt. V.Y.T.PG. Autonomous College, Durg, 491001(C.G.) reserves the right to terminate the Contract awarded at any time during the currency of the Contract without assigning any reasons by giving one month's notice in advance in writing. The Successful Contractor shall be required to give three month's advance notice in writing for termination of the contract, failing which due action shall be taken. If allot part of the contract is terminated in accordance with the provisions contained above, the Office of The Principal Govt.V.Y.T.PG. Autonomous College, Durg, 491001 (C.G.) shall pay charges up to the effective date of termination. However, the termination of the contract shall not relieve the contractor of any of his obligations imposed by the contract with respect the work performed by them prior to such termination.

7. At any time prior to the last date of receipt of bids, Office of the Principal Govt.V.Y.T.PG. Autonomous College, Durg, 491001 (C.G.) may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidders, modify the tender documents by an amendment.
8. The Office of the Principal Govt.V.Y.T.PG. Autonomous College, Durg, 491001 (C.G.) reserves the right of accepting any bid other than the lowest or even rejecting all the bids without assigning any reasons thereof and it shall also, at its own discretion extend the last date of receipt of bids. The ISP shall undertake that he shall comply with all conditions laid down under all applicable statutes, licenses and permissions and undertakes to keep all licenses and permissions valid and subsisting during the period of contract failing which this service agreement shall be liable to be terminated without notice or compensation or any payment whatsoever at the sole discretion of the Department.

11. All disputes and differences arising out of or in any way concerning the contract shall be settled after holding necessary discussions between the parties. However, in the event of any dispute/differences remaining unsolved, the same shall be referred to a sole Arbitrator to be appointed by the principal for this purpose. The decision of the Arbitrator shall be final and binding on both parties.
12. The contractor shall not engage any subcontractor for rendering the services mentioned in this contract.
13. The principal shall be the sole authority to decide on the quality of service rendered by the Contractor. In case the performance of the Contractor is found unsatisfactory, the principal shall have the right to terminate the agreement without notice or compensation or any payment whatsoever at the sole discretion of the principal.
14. The principal shall have the right to withhold any reasonable sum from the amount payable to the Contractor under this contract, if the contractor commits breach of any of the terms and conditions of this agreement or if he fails to produce sufficient proof to the satisfaction of the principal as to the payment of all statutory and other dues or compliance with other obligations.
15. The Income Tax as per Rules shall be deducted from the bill. All statutory deductions such as TDS, etc. wherever applicable, but not limited to this list indicated, shall be deducted from the bills payable to the Successful Contractor at the applicable rates from time to time.
16. If the contractor fails to carry out the work in conformity with the contract documents or if he suspends the work without proper authority or if he fails to execute the work to the proper satisfaction of the authority or commits breach of contract then, the Office of the Principal Govt.V.Y.T.PG. Autonomous College, Durg, 491001 (C.G.) shall have the power to take possession of the materials and stock thereon and to rescind the contract, following which he shall not be entitled to any dues for the remaining period of the contract. 18. The rates quoted by the Contractor shall be firm during the period of contract.
